#### Looking back and learning....

2019-2020 has been an incredible year of growth as we have expanded our work with state governments and demonstrated impact through state level policy shift. Our work has been able to converge support with Parliamentarians as we have been able to leverage our relationship with them and experience of constituency development to be able to create state level impact. From working with the Urban Development department in Manipur to Department of Health in Bihar, we have gotten the opportunity to span across departments and assess how state level planning is translating to ground level scheme delivery.

Our commitment, subsequently, to data driven governance and research has only grown. Using our experiences within state governments, we have been able to develop more indepth research and knowledge pieces that can cut across states. For example, in Manipur we learned that the lack of skill of data entry officers at a block level is a major bottleneck to scheme enrollment in key government programs. We were able to take this learning to our district work in Jharkhand and translate it to action. Being present in multiple states has allowed us this opportunity.

Going forward, in 2020-21 we plan on continuing to work with more state and districts governments on issues of livelihood, health and social safety net and continue engaging key constituents like Parliamentarians through this process.



Indian bureaucrats are the primary medium of executing development programs worth over \$250 billion annually in areas of health, education, gender, infrastructure and environment. Unfortunately, for every 100,000 people, there are only 125 government administrators, and sparse data points. Similarly, legislators are responsible for oversight of 30.42 crore of budgetary allocation. However, India has 543 legislators for 1.34 billion Indians, i.e, a single legislator represents almost 25 lakh Indians. Severe understaffing has led to major bottlenecks in welfare projects.

This is where Swaniti Initiative comes in. Swaniti saw a tremendous opportunity in building networks between state governments, policy leaders, private sector and communities throughout the world, equipping them with a mix of problem-solving tools, data & research insights, and on ground support. We work extensively across rungs of governance to deliver development solutions to the bottom of the pyramid in grassroots India. Our core ethos is to engage with the government to catalyze development and bridge the existing knowledge gap by developing efficient and impactful frameworks and leveraging data-driven tools.

### Andhra Pradesh

Swaniti Initiative is currently working with the government of Andhra Pradesh to strengthen policy planning processes through bottom up feedback systems. We anticipate the citizen feedback will allow for inclusion of last mile beneficiaries and equal access to all citizens for basic government programs.



# **Manipur and Tripura**






#### **KEY ACTIVITIES**

- The Swaniti Team, in its stakeholder interactions, identified that state governments were not using the PFMS platform, and recommended changes.
- They further set up mechanisms to consolidate inputs in an IEC network for swift uptake and fewer rejections.
- The team worked in collaboration with the state government to solve logistical challenges such as that of manpower and capacity building.

#### SWANITI'S IMPACT

- Through our recommendations, we **impacted** 1,46,622 beneficiaries
- The project helped in initiating payment of INR 103
   cr on PFMS for Manipur and Tripura
- Beneficiary verification for PMAY formalised, payment process timespan reduced from 96 hours to 48 hours, regular reporting on scheme progress for every individual beneficiary
- Payment error and failure as per last payment is zero in Department of Urban Development Tripura

## Uttar Pradesh & Bihar



Swaniti works with the Human Liberty Network to help analyze the conditions of the vulnerability of marginalized population in UP and Bihar. We further provide insights to NGOs and the government to help strengthen the policies of the governments in UP and Bihar to tackle deteriorating situations of debt bondage and human trafficking.

- Connected partners with leading experts and policy makers for knowledge building.

## Jharkhand

Swaniti Initiative has set up District Mineral Foundation Trusts (DMFT) in **four mining affected districts** in Jharkhand - **Ramgarh, Ranchi, Godda and Pakur**. These Planning and monitoring units support the District Administration with the aim of benefiting people affected by mining related activities and improving their living conditions.

#### **KEY ACTIVITIES:**

- Conducting Need Assessments in mining villages
- Supporting gram sabhas in preparing annual action plans
- Supporting the district administration in planning interventions
- Developing monitoring frameworks for on-going projects
- **Carrying out stakeholder interactions** through community consultations and interviews with officials.

#### SWANITI'S IMPACT:

- Using insights from local data collection and discussions, our Jharkhand team got a total of 2396 projects approved by the Governing Council
- The team oversaw the upgradation of facilities in the Ramgarh district hopital leading to a 90% reduction in referrals to State hospitals
- The team created of a comprehensive and sustainable system to ensure projects are completed in a timely manner, and regular updates are given.

# Rajasthan and Punjab



Swaniti Initiative, in partnership with the North India office of the U.S. Embassy New Delhi, implemented the "Supporting Her Empowerment via Digital Tools" - a workshop series that seeks to increase and broaden women artisans' market access. We worked with CSO and NGOs to provide trainings on digital tools and strategies required to grow businesses beyond the local marketplace and contribute to the economic growth women artisans and their communities. Swaniti held two workshops in Punjab and Rajasthan. In addition to the workshop, participating artisans would be provided with dedicated handholding for a six-month period.



#### SWANITI'S IMPACT

- Participants reported an increase in online traction within 2 months of each workshop.
- Participants also trained other artisans, helping us reach 5 times the people attending the workshops.
- Working with Aajeevika National Rural Livelihoods Mission Swaniti took trainers through sessions on holding similar programs.

#### PARTNERSHIPS ESTABLISHED

- Flipkart Samarth: A breakthrough initiative by India's leading e-commerce marketplace Flipkart, they onboarded participants to help them break onto e-commerce.
- Lal10: A social enterprise building tech tools to improve market linkages for artisans, they helped artisans understand how to use tech to interact with customers easily.

## Fighting Forced Migration Across 11 States


Swaniti Initiative is the technical assistance partner for the India Working Group Against Trafficking (IWG), a network of 22 NGOs working across 11 states who are doing grassroots work to combat forced migration. Swaniti is working with IWG at a policy level to help them understand the ecosystem. Below is a glimpse of the work Swaniti has carried out this year.

#### Engaging with Govt Stakeholders

- Initiated engagements with key policy stakeholders such as members of Labour Standing Committee
- Arranged a closed-door interaction in February 2020 with policy makers for IWG partners to showcase their work.
- Facilitated the creation of a recommendation paper by IWG submitted to NITI Aayog - the government think-tank.
- Submitted letters to the PMO on proposing recommendations to combat distress of migrant workers.

#### **Building Capacity of IWG Members**

- **Prepared comparative notes** on ISMWA and the OSH Code, 2019,
- **Conducted periodical webinars and meetings** for IWG partners on knowledge building.
  - Prepared detailed research methodology, and evidence collection tools for IWG partners to facilitate a coordinated data collection strategy
  - Leveraged Swaniti's experience with social media to work on a comprehensive strategy for online activism.

# Protecting children's rights

Since Swaniti Initiative has the unique advantage of having an ear to the ground, as well as consistent interactions with Parliamentarians across party lines, a unique forum called the Parliamentarians' Group for Children (PGC) was set up in 2017 by Swaniti Initiative and UNICEF India. PGC is a platform that convenes, informs and engages Members of Parliament (MPs) on issues of children's rights.

#### **KEY INITIATIVES**

- **Capacity building of Parliamentarians** for creating improved and sustainable policies
- Roundtable conferences with section experts
- Creating a safe platform for cross-party discussions on issues of children's rights at quarterly meetings
- Creation of a newsletter to inform Parliamentarians of latests news and best practises in the realm of child rights.

#### SWANITI'S IMPACT

- Onboarding 250 Parliamentarians to the PGC platform who pledged to work towards better child rights.
- Creation of a core PGC committee
   headed by stalwarts such as Ms. Vandana
   Chavan, Mr. Gaurav Gogoi, Dr. Amee
   Yagnik, Mr. Ravi Prakash Verma, Dr.
   Sanjay Jaiswal, Dr. Vikas Mahatme and
   Ms. Heena Gavit.
- Creating media engagement pieces through videos and opinion pieces to highlight challenges and achievements.





# Creating economic opportunity



Swaniti collaborated on a project with UBER India, that looked to improve economic opportunities for its partners by streamlining formalisation through Uber. As a part of analytical advocacy, Swaniti conduct primary and secondary research to assess the impact of Uber in employment generation, formalisation, skill development within the gig economy through the lens of political representatives.



#### **KEY ACTIVITIES**

- To build a study on the 'Impact of Tech Aggregators on the Indian Economy', the **Swaniti team first carried out a secondary research** to understand the overall impact of aggregators globally and nationally.
- Post that, one-on-one interviews were carried out with 30 key parliamentarians to gauge the perception of the Political Economy on these aggregators and their impact on the gig economy
- In addition, a closed door session was organised which witnessed 15 MPs in attendance across party lines to better understand the gig economy, potential of job creation through Uber, challenges for the labour market and the way forward.
- The **meetings resulted in a report** on best practises in designing effective policy interventions, protecting the interests of driver partners and aggregators and streamlining formal employment for UBER India.

### ROUNDTABLES



Swaniti Initiative has held multiple roundtables every Thursday during the Parliament session. Swaniti believes, that by bringing Parliamentarians and section experts together to converse on India's most pressing problems, we can help quicken the process of problem solving.

Our aim with the closed door roundtables is to equip Parliamentarians with information that helps them take data and evidence-based decisions. In the past year, we have hosted roundtables on matters such as the annual budget, child rights, the gig economy, creating vocational jobs in districts, healthcare innovation and budgeting, and many more.

### **SWANITI TALKS**



Swaniti Initiative believes that great ideas germinate through candid discussions and based on this premise organizes "Swaniti Talks" that had the youth of the country, and eminent politicians come together for a discussion. The Initiative was to foster an environment where constituents have the opportunity gain insights about governance and development, express their thoughts and ideas and network.

We saw the participation of MPs like Ms. Aparajita Sarangi and Mr. Lavu Sri Krishna Devarayalu for Swaniti Talks sessions in the past year.

#### > SCALE UP OUR WORK

We believe that our research work, coupled with our on-the-ground experience have prepared us to share valuable development support with a sizeable cohort of MPs. Additionally we also see the prospect of working with more MPs as an opportunity for us to share our knowledge tools with a bigger population and engage in a two-way process.

#### > INCREASE OUR OUTREACH

Through effective use of media, we aim to bring development concerns to the notice of the public and help them engage with their Parliamentarians. In the coming year, Swaniti will make a concerted effort to increase our outreach to constituents through social media platform (such as Twitter and Facebook), the print media (by aiming release to information about development and governance periodically) and Swaniti Talks.

#### > STRENGTHEN OUR SUPPORT

We aim to continue strengthening our human capital and donor support. Swaniti's current team and alumni consist of tremendously talented professionals and we expect to continue building on this talent within the team. Additionally, the team looks forward to a year of strong partnerships and collaboration with different organisation towards our goals of helping the governance system function well.
