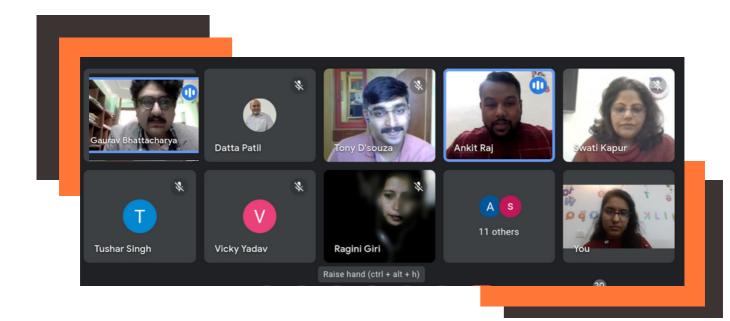


# HIGHLIGHTS@SWANITI



### **#UNFOLDING SWANITI**

Roundtable is an initiative of Swaniti to build a common platform/forum for multiple stakeholders in the development & policy space to come together, collaborate, and share knowledge. Unfolding Swaniti is also intended at increasing the visibility of interventions of Swaniti in different states under various verticals. The latest roundtable was organized under the Social Protection vertical where the West Bengal team anchored it. The team highlighted the intervention of West Bengal in the districts of Alipurudar, Jalpaiguri, Coochbehar, and Darjeeling to strengthen tea garden workers' awareness, access, and inclusion for accessing social protection schemes. The team shared how they were able to record the grievances of the community through the in-house tool 'Jaano' through their Soochnapreneurs. The roundtable was attended by prominent Civil Society Organizations - Action for Food Production (AFPRO), Pratham Education Foundation(PEF), USAID, Video Volunteers, Yuva Rural Association, Absolute, KABIL, and SEWA Bharat. The CSOs raised queries about the project, their challenges, and what is the best way to approach government stakeholders in the geography.

# JH-RESET @SWANITI



### **Solar Irrigation**

The JH-RESET project aims to promote efficient energy transition in the district through the installation of solar lights including High Mast, Mid Mast, and Street Lights. With the constant support of the Green Associates to the district administration, more than 5000 lights have been installed across 8 districts. The Associates have played a crucial part in mobilizing the funds from various government schemes for smoothening the implementation process.

### **Case Study**

Ranchi's topography is a major cause for an acute shortage of water in many areas, disrupting the efficiency of public infrastructure. To address the issue of drinking water shortage, our Green Associate, Sumit, had been coordinating with AMNAA Projects to pilot the installation of Atmospheric Water Generators (AWGs). As a result, two AWGs were installed. The first machine with a capacity of producing 60 litres of water per day was installed on 9th November in Govt upgraded Middle School, Jaidiha. The second, with a capacity of producing 25 litres of water per day was installed in Vikas Bhawan, Ranchi, on 10th November. This cost-effective machine was provided free of charge and is expected to reap the benefits over time.

## **Technology for Education**

Swaniti Initiative has its presence across the major mining-affected districts of Jharkhand to implement developmental and welfare projects. Our teams are facilitating projects aimed at improving the healthcare and educational infrastructure along with strengthening the existing and creating new livelihood avenues. The project at Pakur works with the district administration to improvise the quality of education and enabling access to alternative livelihoods for the community members

### **Case Study**

Technology is part and parcel of our lives. Today, it is essential that we incorporate technology in our education, particularly in remote and rural areas of the country. As Internet penetration and smart phones are exponentially increasing within the country, some children still lack access to computers and other technology tools which could accelerate their learning. The district administration of Pakur, therefore, decided to come up with a solution to provide access to the students without the overheads of maintenance & repair of computers. They set up **Tab Labs** in 12 schools of the district where 30 tablets were provided to each school, along with a personalized app based on the curriculum of the student to help them learning according to their need. The tab lab will impact the lives of more than **10000+ students** studying in the government school. increasing the attendance.

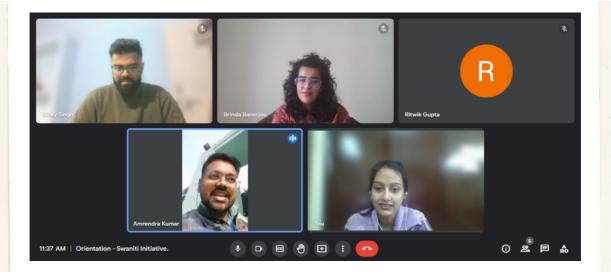
